

Transcript from Probate Office document.

This is the last Will and Testament of me Edmund Maw of Field House, Epworth in the County of Lincoln Gentleman I desire and direct that my body shall be cremated and that the ashes shall be buried in the grave of my parents in Epworth Churchyard I give and bequeath to my friend Robert William Tonge and my Cousin Edmund Tonge Flower the Legacy or sum of Thirty pounds each I give devise and bequeath all my houses Closes lands and hereditaments situated in the parish of Epworth aforesaid and all other Real Estate at Epworth (if any) or elsewhere and also all my moneys, stocks shares, investments, furniture and household effects and all and every other my personal estate and effects of every nature and description unto my Cousin Annie Tonge Flower for her own absolute use and benefit subject to the payments of my just debts funeral and testamentary expenses the cost of cremation of my body, all death duties payable on my death and the two Legacies herein before bequeathed. I desire to put on records the fact that my said Cousin Annie Tonge Flower has for forty one years been Housekeeper and Manager for my late Father and myself and that during the whole of that period she has performed all duties with care thoroughness and efficiency and to the great comfort and well-being both of my late Father and myself and I appoint the said Robert William Tonge Annie Tonge Flower and Edmund Tonge Flower joint Executors and Trustees of this my Will and I revoke all former Wills and testamentary dispositions and declare this only to be my last Will and Testament as witness my hand this Twenty First day of July One thousand nine hundred and fifty six.

Revenue Officer on the said Affidavit that £3219-7-3 on account of Estate
