

Transcript from Probate Office document.

THIS IS THE LAST WILL AND TESTAMENT of me LUCY MAW of "Ballangh" Deganwy in the county of Caernarvon widow 1. I hereby revoke all former wills and testamentary dispositions made by me and declare this to be my last will 2. I appoint my daughter Margaret sole executrix of this my will 3. I give a legacy of Fifty pounds free of duty to Nurse Emma Schofield of The Oldham Nursing Association Union Street West Oldham in the County of Lancaster 4. I give a legacy of five pounds free of duty to my friend Edith Taylor of "Bryn Mair" Penmaenmawr 5. I give all my property situated at and near Belton and Epworth near Doncaster in the county of Lincoln comprising the property known as Field House with the buildings and land appertaining thereto Epworth aforesaid the parcel of land at Eilers Field Epworth aforesaid with the Windmill thereon and the entirety of the cottage known as "Mill Hill Cottage" Epworth aforesaid also a parcel of land near Belshaw Epworth aforesaid at one time in the occupation of F C Oliver unto my nephew Edmund Maw of 54 Broadway Stretford London S15 6. I devise and bequeath all the remainder of my estate both real and personal including any property over which I may have power of appointment) to my daughter Margaret Maw for her own use and benefit absolutely subject to the payment thereof of my debts and funeral and testamentary expenses and the legacy duty on the before mentioned legacies 7. Lastly I express the wish on my death to be cremated In witness whereof I have hereunto set my hand this Thirteenth day of February One thousand nine hundred and thirty nine

And it is further certified that it appears by a Receipt signed by an Inland Revenue Officer on the said Affidavit that *£382:2:5* on account of Estate Duty and Interest on such duty has been paid.
