

Admon Bond Richard Maw of Epworth 1832

Know all Men by those present That we Edmund Maw of Epworth in the County of Lincoln Farmer, Robert Gervas and Thomas Gervas both of Epworth aforesaid Spirit Merchants are firmly bound unto the Worthshipfull William Baltine Doctor of Law Vicar General and Official Principal of the Right Reverent Father in God John by Divine Permission Lord Bishop of Lincoln lawfully constituted in the penal sum of Four hundred Pounds of good and lawful money of Great Britain to be paid unto the said William Baltine or to his certain Attorney his Executor Administrators or Assign To which payment well and truly to be made we oblige and each and every us by himself and themselves for the whole our and each and every of our Heirs Executors and Administrator and the Heir's Executors and Administrators firmly by those Present Sealed with our Seals dated the eleventh Day of June in the Second year of the Reign of our Sovereign Lord William the fourth by the Grace of God of the United Kingdom of Great Britain and Ireland King Defender of the faith and so forth and in the year of our Lord One thousand Eight Hundred and thirty two,

The Condition of this Obligation is such that if the above *bounden* Edmund Maw the lawful Son and Administrator of all and singular the Goods Chattels and Credits of Richard Maw late of Epworth aforesaid deceased do make or cause to be made a true and perfect inventory of all and singular the Goods Chattels and Credits of the said deceased which have or shall come to the hands profession or knowledge of him the said Edmund Maw or into the hands and possession of any other person or persons for him and the same so made do exhibit or cause to be exhibited into the Registry of the Consistory Court of Lincoln at or before the last day of September next ensuing and the same Goods Chattels and Credits and all other the Goods Chattels and Credits of the said deceased at the time of his death which at any time after shall come to the hands or possession of the said Edmund Maw or into the hands or possession of any other person or persons for him do well and truly Administer according to laws and further do make or cause to be made a true and just Account of his said Administration at or before the last Day of June 1833 and all the Rest and Residue of the said Goods Chattels and Credits which shall be found remaining upon the said Administrators Account the same being first examined and allowed of by the judge or judges for the time being of the said Court shall deliver and pay unto such person or persons respectively as the said Judge or judges by his or their *decree* or sentence pursuant to the time Intent and meaning of an Act of Parliament made in the Two and twentieth and three and Twentieth years of the Reign of his late Majesty King Charles the Second *entitled* An Act for the better settling Intestates Estates shall limit and appoint and if it shall hereafter appear that any last Will and Testament was made by the said deceased and the Executor or Executors thereon named do exhibit the same into the said Court making request to have in allowed and approved accordingly if the said Edmund Maw above bounden being thereun required do render and deliver the said Letters of Administration of such Testament being first had and made in the Court then this Obligation to be void or else to remain in full force and Virtue,

On the eleventh day of June 1832 Edmund Maw the Administrator within named was duly sworn and also made oath that the personal estate and effects of the deceased at the time of his death did not amount in value to the sum of Two hundred Pounds.
