named as soon as conveniently can be after my decease I give & bequeath unto

Glasgow the sum of one hundred pounds I also give and bequeath unto my
Daughter Christiana Campbell the sum of two hundred pounds to be paid into
her own proper hands upon her own receipt & for her sole separate use
and as to all singular my furniture plate Linen & China debts sum & sums
of money money in the British or other funds Bills Bonds Notes Mortgages
& securities for money & all other the personal Estate & Effects whatsoever
and whatsoever of what nature or kind soever the same may be which I
may happen to be possessed of interested in or entitled unto at the time of my
decease and also to all such Real Estate which I may happen to be seized or
possessed of or interested in or entitled unto whether in possession reversion or
remainder or expectancy subject to the payment to the above mentioned & to
Legacies & of my debts funeral & Testamentary expenses as aforesaid I give &
devise & bequeath the same unto Sir James Allan Bart of Bedford Square &
in the County of Middlesex Knight Robert Campbell of Genoa in Italy &
Lieutenant Thomas Croft of Glasgow in Italy Merchant their Executors
Administrators & Assigns To hold the same unto & to the use of &
them the said Sir James Allan Bart Robert Campbell & Thomas Croft in
their said Executors Administrators & Assigns according to the several natures
of properties thereof respectively upon the trusts & to the ends intents & in
purposes hereinafter mentioned expressed & declared of governing the same
that is to say upon trust that they the said Sir James Allan Bart Robert
Campbell & Thomas Croft or the survivor or survivors of them their or
their said Executors Administrators or Assigns do & shall with all convenient
speed after my decease collect get in receive all such part of my personal &
Estate as shall consist of money owing to me whether upon Bills Bonds
Notes Mortgages or other securities or otherwise and do and shall sell &
dispose & convert into money all such part or parts thereof as shall not
consist of money or securities for money & do & shall stand & be possessed of
interested in the same upon trust from time to time to place out & invest &
continue the same at Interest in some or one of the public Stocks or in
funds or on Government or Real Security in England or elsewhere or in
such other mode as may to them seem most advisable & most conducive
to the Interest of my said Executors and to stand & be possessed of & interested in
such Stocks funds & securities when purchased & of all & every the Stocks
or funds which I may happen to be possessed of at the time of my decease
& of accumulations & additions thereto & also of all my Real Estate & of the
Rents Issues & profits thereof upon trust by & out of the Dividends & in
Interest thereof & of the Rent Issues & profits thereof to pay unto my
Sister Mary Campbell Widow of John Campbell Esquire deceased one

annuity or clear yearly sum of one hundred & fifty pounds for & during the
 term of her natural life without any deduction or abatement whatsoever &
 upon further trust out of the dividends & interest thereof & of the rents
 issues & profits thereof to pay unto Isabella Dr. & Jean of Derwain in the
 Island of Mull one annuity or clear yearly sum of ten pounds for & during
 the term of her natural life without any deduction or abatement
 whatsoever and I do hereby direct that each of these annuities be paid
 half yearly & that the first half yearly payment be made immediately
 after the expiration of six Calendar Months from the time of my decease and
 upon further trust to set apart so much of my said Estate as shall be of the
 value of six hundred pounds to pay the interest & dividends thereof &
 towards the maintenance education & bringing up of Mary Ann Croft
 John Croft Charles Croft Louisa Croft & Charlotte Croft the Children
 of my sister Elspat Arbuthnot Croft deceased the late wife of the said
 Thomas Croft until they shall severally & respectively attain the age of
 twenty one years and to pay transfer & assign the said principal sum of six
 hundred pounds to them in equal shares & proportions when & as each of
 them as are sons shall severally & respectively attain that age or when
 & as each of them as shall be a daughter or daughters shall attain that
 age or be married and in case one or more of the Children of the said
 Elspat Arbuthnot Croft deceased shall die before attaining the said
 age of twenty one years or if a female or females before attaining that
 age or being married then it is my will & I do hereby direct that the
 share or shares of him her or them so dying shall be paid assigned &
 transferred unto the survivor or survivors of them when & as they the or
 she shall respectively become entitled to their his or her original shares or
 share and subject to the payment of the said sum of six hundred pounds
 to the Children of my said sister Elspat Arbuthnot Croft deceased as &
 aforesaid & of the said legacies & annuities & also of my just debts as &
 aforesaid before mentioned I do hereby direct my said Trustees to stand & be
 seized & possessed of all the said real residue & remainder of my Real and
 Personal Estate & Effects upon further trust to pay assign & transfer one
 equal third part or share thereof (the whole into three equal parts or
 shares to be divided) unto my nephew Robert Campbell his heirs &
 Executors Administrators & assigns absolutely & for ever and upon trust to
 pay assign & transfer one other equal third part or share thereof unto my
 sister Christiana Campbell her heirs Executors Administrators & assigns
 absolutely & for ever and as to the remaining one third or share thereof upon
 further trust to pay assign & transfer the same unto the said Children of a
 my said sister Elspat Arbuthnot Croft deceased in equal shares &
 proportions when & as they shall severally & respectively attain their age
 or respective ages of twenty one years with the like benefit of
 survivorship as is extended to them with regard to the six hundred &
 pounds aforesaid given and bequeathed to them the Rents interests &
 dividends & Annual proceeds thereof in the mean time to be paid & applied
 for & towards their maintenance education & support the surplus thereof
 if any to be laid out & invested in the same sorts or funds out of which they
 will be entitled to receive their proportionate parts or shares when & as they
 shall respectively attain the age of twenty one years or in case the females
 be married as is aforesaid expressed And I hereby nominate constitute
 & appoint my said Trustees to be Executors of this my will to each of a
 whom I give & bequeath a Mourning Ring of the value of five Guineas
 and I also direct my said Executors to present to Lady Park & to Dr. &
 Ann Sherman a Mourning Ring each of the like value and my will is
 & I do hereby declare that my said Trustees of this my will or any of them
 their or any of their Executors Administrators or assigns shall not be charged
 or chargeable with or accountable for any sum or sums of money whatsoever

other than such only as by virtue or in pursuance of this my Will shall be actually received or come to this or their hands respectively and all not be answerable or accountable the one of them for the share of them or for the receipts payments acts & wilful defaults only or defaults of the others or share of them but each of them for this own receipts payments acts & wilful defaults only their joining in any receipt or receipts for the date of it in conformity notwithstanding nor shall they or any of them be answerable or accountable for any loss or damage which may happen in or relate to the said Real & Personal Estate or the management or execution of the trusts or executorship of this my Will without this or their respective wilful neglect or default and that they my said Executors of this my Will on each & every of them their & each & every of their Executors Administrators & Assigns may from time to time deduct & retain in this or their hands & reimburse themselves & themselves respectively out of all or any of the monies which by virtue of this my Will shall come to this or their hands respectively all such costs charges & expenses as they or they shall pay or expend sustain or be put to in the execution of the trusts of this my Will and lastly I hereby revoke & make void all former Wills by me at any time made and I do declare this only to be & contain my last Will & Testament in which I have written I the said Samuel Maclean Esq. I the said Testator have to this my last Will & Testament contained in three sheets of paper set my hand & seal that is to say my hand to the two first sheets thereof & my hand & seal to this fourth sheet which last sheet this fourth day of March in the year of our Lord one thousand eight hundred & twenty eight I.
