William PASK was born in circa 1710.¹ William married Ann MAW on 8 May 1738 in Scotter, Lincolnshire <pd423.htm>.^{1,2} William PASK made a will dated 12 November 1760 In the Name of God Amen I William Pask of Scotter in the County of Lincoln, Farmer, Do hereby Revoke all former wills by me at any time heretofore made and do make and Ordain this my last Will and Testament in the Manner and form Following (that is to Say)

First, I Give and Bequeath unto my Dear Wife Henrietta Maria in Case she shall be living at the time of my Decease the full and Just Sum of Six Pounds Yearly and every Year for and during the Term of her natural Live to be paid to her by my Executors hereinafter named the first Payment thereof to begin and be made at the end of Twelve Months from the Time of my Decease.

Also I Give and Bequeath unto my Daughter Elizabeth, now the wife of John Airy, in case she shall be living at the Time of my Decease the full and Just Sum of Two Pounds ten shillings Yearly and every Year for and during the Term of her Natural Live to be paid to her by my said hereinafter named Executor free, clear and absolute from control or intermeddling of her said Husband and her own Receipt and no other shall be a sufficient discharge for the Payment of the same from time to time to my said hereinafter named executors, the first Payment thereof to begin and be made at the end of Twelve Months from the Time of my Decease.

Also I Give and Bequeath unto my Daughter Ann Pask the full and Just Sum of One Hundred Pounds to be paid to her by my said hereinafter named Executors when she shall attain her age of Twenty One Years. In Case she shall be under that age at the time of my decease, then my wife and [illegible] in Case she shall have attained her said Age of Twenty One Years at the time of my Decease that her said Legacy of One Hundred Pounds shall not be paid until the end of Twelve Months from the Time of my Decease and I do hereby Direct the sum to be paid to her by my said hereinafter named executors accordingly.

And Last as to all the Rest of my Goods, Chattels and Personal Estate whatsoever and wheresoever after my Just Debts, Funeral Expenses, Legacies and Bequests are paid and [illegible] I do hereby make my two Sons William Pask and John Pask Joint Executors of this my last Will and Testament. In Witness whereof I have hereunto set my hand and seal this Twelfth Day of November One Thousand Seven Hundred and Sixty [illegible]. - Wm Pask
