Thirthy shillings, to be paid by my Executor or Executors to the Churchwardens and ... of money of the said Towns to be by them distributed and dealt amongst the poor of said Towns, where most need shall be, at their discretion and my will and meaning is that there shall be , not other dole, dealt or given at my buryall Also whereas my brother Charles Mawe hath bargained and sold unto me and my heirs all his freehold lands and tenements in Snape in the county of Suff beinge of yearly ... of seven pounds and ... in the bewurt and occupation of the widow Smith late wife of Thomas Smith late of Snape above said deceased, my will and meaninge is That if the same shall not be ... by my said brother in my life tyme, that then the said Charles shall by good ... at ... and ... over the same unto such ... to be named and appointed for that purpose by William Clover of Ath orfrodington in the county of Suffolk gent and some others of the ... Inhabitants and ... of the Town of Rendlesham aforesaid and their heirs for ever, to the .. of the said Inhabitants of Rendlesham for and towards the payment of Rents and fifteens commonly called the To
